The First \$10,000 Half Mile Track Prize

By Ed Keller December 12, 1979

An interesting question that could be placed before any panel of harness horse experts, which would in all probability draw a series of negative answers, is, "Where was the first \$10,000 feature race ever contested over a half-mile track, naming both track, year and the conditions governing same?"

Just think back to the time you saw your first \$10,000 race over a half-mile track. It has to be a few decades or so back you readily admit. But even so you are then way off base. The thinking of most of course will be that it was staged by one of the leading tracks of that era, by officials who were progressive and knew the value of an outstanding race feature.

Again one would be far off base. Ever heard of the Clinton County Agricultural Society? Unless you were a native of that sparsely settled area of northeastern New York State, or happen to be among the few summer tourists who visit the section that borders on the upper west shores of Lake Champlain, and have a strong liking for horses and the country fairs, you have never had the opportunity to enjoy the annual four-day early September exhibition at Plattsburgh, the largest community of that area. Yes indeed, this would be the last place in the world of professional sports that you would ever expect to find the first rich half-mile harness racing feature.

If one could have been present in the night that the fair board members of the Clinton Agricultural Society met to decide yes or no on such a momentous and risky undertaking, they undoubtedly would have heard plenty of fireworks. But when the meeting was over the forward thinking members of the fair board had made their point, and, immediately the news went out, the coming 1911 four-day fair and racing would headline the first \$10,000 harness race ever contested over a half-mile track anywhere in the world.

In addition to the big feature, there would be a Consolation for those starting in the big race and not earning any money. The balance of the four afternoon programs was made up of classes from the 2:29 candidates down to the faster 2:12 eligibles, each for \$500, with an eight-County local race for \$300.


The \$10,000 prize included one of the outstanding features of that or any previous racing season. The race was to be for a single dash, a Handicap over the longer mile and one-half route. These two features certainly did

set the tongues to wagging wherever the sideline critics gathered, for heated debates were as much a part of racing in that area as the racing itself – cracker barrel experts had their own followings.

When it came to declare starters, the event drew a banner list of twelve. Then the handicapping committee went to work.

That was long before legibility certificates carried the horses previous starts, and when other information on any horse's previous starts, and when other information on any horse's speed qualifications, like a quick call today to the U.S.T.A. offices at Columbus, would bring forth. The race committee had to decide on the various handicaps according to the best information that could be secured as to the racing abilities at that time.

It had been announced that the starting of the Handicap would be like that used to start the \$50,000 American Trotting Derby at Readville Park Grand



Circuit meeting of 1908, which was to remain for several decades as the richest single dash ever contested by harness horses. This system was governed by starters placed at the various handicaps, each holding an electric button. When the starters had their horses properly lined in front of their handicap, they pressed their button. When all buttons were pressed simultaneously, they released a big gong which signaled the start of the race.

Five of the field of twelve were placed on the scratch handicap, the 2:20 post, the wire. Starter

starters were in charge of J.I. Olivette. Two others were spotted at the 2:17 handicap in charge of T.H. Moone, and the high handicap at the 2:16 station was given to Johnnie Medium, where C.F. Carpenter was in the starters stand.

At the start Walter S., one of the five from the scratch position, took the lead and set the pace to the half. As the field battled past the first mile Dr. Thorne had taken command, who started from the 2:19 position. As the field hit the backstretch for the third time, Driver Lang had worked his way up from his last position in the bulky field with Johnnie Medium, and was pressing strongly for the lead, though several lengths back.

Dr. Thorne, all-out at the mile and one-quarter pole, went on a break, and this let Johnnie Medium take over. Both Colonel S. and Walter S. applied the pressure in the final quarter, but Johnnie Medium had a safe margin at the finish.

When driver Lang brought his gelding back for the presentation ceremonies, the more than 10,000 fans who had turned out for the fair's biggest day ever, let out a roar that was heard way across the lake at Burlington, Vermont. Six monies were divided by the winners, as


follows; Johnnie Medium, \$3,000; Colonel S., \$1,800; Walter S., \$1,600; The Princess, \$1,400; Larabie Gyp, \$1,200, and Patsy Hendrick, \$1,000 – \$10,000 in all. As a dollar was a strong commodity in those days, it was a profitable afternoon for the first six horses to finish.

In the Consolation division, also at a distance of a mile and one-half, the winner was Dr. Thorne, over Baron Wedgewood, Kings Flower and Dan K, with Lady L and Minnie Grattan completing the field.

Times for the two handicaps were, 3:35, the mile in the \$10,000 feature in 2:22 off an opening 1:10 half, and in the consolation the finish in 3:36 1/2.

Quite an afternoon it was at the annual Clinton County Fair, Plattsburgh, N.Y., on the shores of Lake Champlain, just about the last place in the race horse world that one would expect to see a \$10,000 Handicap feature over a half-mile track.

Editor's Note – This article and the one which appears on page 156 were among several stories which reached us in a large envelope shortly before the writer, Ed Keller, died. We plan to publish others during the coming year.

General Prohibitions and Requirements

- No person shall bring or have present an animal on the fairgrounds during a fair which is not qualified under NYS regulations.
- No person shall present an interstate or intrastate certificate of veterinary inspection that has been altered by anyone other than the issuing veterinarian.
- Animals demonstrating clinical signs or other evidence of infectious, contagious or communicable diseases shall not be allowed on the fairgrounds during a fair.
- Representatives of the Commissioner may deny admission to or require removal from the fair premises, or require the segregation of any animal showing signs of or exposed to any infectious, contagious or communicable disease.

NOTE: The fair board of directors has the authority to reject unworthy or unsightly exhibits for reasons other than infectious, contagious or communicable disease (Part 350.10). The state veterinarian or animal health inspector will bring questionable exhibits to the attention of the fair board.

 All animals presented that originate from a location other than New York shall meet all New York State importation regulations appropriate to the species in addition to the fair animal health requirements.

Certificates of Veterinary Inspection (CVI)

- Cattle, sheep, goats, swine, llamas, alpacas, deer, and misc. ruminants, require a valid CVI to enter the fairgrounds.
- The CVI must be issued by a Category 2 accredited veterinarian.
- All animals must be officially identified. All manmade ID must be recorded. Note that there are new animal identification

requirements for cattle and swine.

Refer to Animal Identification section below for more information.

- Only one species is allowed per certificate.
- The type and duration of certificate required depends on the origin of the livestock.

New York Origin Livestock:

- A valid intrastate CVI (AI-61) is required.
- Each animal must be individually identified on the CVI (see below).
- The CVI must be issued on or after May 1 of the current year.

Out of State Origin Livestock:

- All animals entering New York State must satisfy import health and test requirements for that species and be accompanied by a valid interstate CVI.
- The interstate CVI is valid for 30 days from the date of CVI inspection. During the fair season (July 1 through Labor Day) valid CVI's can be used multiple times for entrance into fairs. The initial entrance into a fair must be within 30 days of the date of CVI inspection. In order for the CVI to be used for a later fair, it must be dated and initialed by a state official noting the location of the initial fair. A change in health status or eligibility of an animal necessitates the generation of a new CVI.

Animal Identification

• ALL MANMADE ID MUST BE RECORDED

- Cattle must be identified by an official USDA radio frequency identification (RFID) eartag, commonly referred to as an "840 RFID tag," or an equivalent official RFID tag if the animal was tagged in another country. Cattle which are already identified with 840 visual eartags will be exempt from the 840 RFID tag requirement.
- Sheep and goats must be identified by official scrapie identification (see sheep and goat sections below).
- Swine must be identified by an official USDA radio frequency identification (RFID) eartag, commonly referred to as an "840 RFID tag" or an equivalent official RFID tag if the animal was tagged in another country.

Swine which are already identified with 840 visual eartags will be exempt from the 840 RFID tag requirement. Nursing piglets do not have to be individually identified if the sow is correctly identified on the CVI and the number of piglets in the litter is noted on the CVI.

- Deer/elk must be identified with an official eartag.
- Llamas and alpacas must be identified by official ear tag or microchip.
- Misc. ruminants must be identified by unique eartag or microchip.
- A complete written description is sufficient identification for horses entering New York accompanied by a CVI. The description must match the EIA test record. Horse sketches and descriptions should reference color pattern, hair whorls, chestnuts, scars and other markings as necessary to uniquely identify the horse. Tattoos and microchips if any should be included. "Bay, no markings" is not an acceptable description for a CVI or EIA test record.
- NOTE: If you are exhibiting animals identified by microchip a working reader must be supplied by the exhibitor.
- For questions on animal identification please contact your veterinarian or our office at 518-457-3502.

Rabies Vaccination

- Rabies vaccination is required for all species for which there is a USDA licensed vaccine available (cattle, horses, sheep, dog, cat, ferret) and that are 4 months of age or older on the date of admission to the fair.
- Vaccine must have been administered within the past 12 months. The exception is Imrab LA vaccine used in sheep which protects for 3 years after the second annual vaccination (consult your veterinarian).
- The rabies vaccination requirement must be met on the day of admission even if the animal was previously admitted to a fair when too young to vaccinate.
- NOTE: Individual fairs can require animals for which there is no approved rabies vaccine to be vaccinated for rabies. The requirements outlined above would apply. The fair is responsible for notifying exhibitors. The **New York State Fair** requires rabies vaccination for all livestock species entering the grounds.

Acceptable Proof of Rabies Vaccination

- Acceptable proof of rabies vaccination must include a signed written statement from the veterinarian administering the vaccine or a valid certificate of veterinary inspection that has the vaccination listed and is signed by the Category 2 accredited veterinarian.
- •Acceptable proof of rabies vaccination must include the name of the product used, the date of administration and the duration of immunity if longer than one year.
- If the statement of rabies vaccination is included on an EIA test record, it must be signed separately in addition to the required EIA test record signature.
- NOTE: Rabies titers are not acceptable proof of rabies protection and cannot be used to meet entry requirements.
- Acceptable proof of vaccination for dogs is a valid vaccination certificate or a copy of the dog license that contains the rabies vaccination information.

BVD-PI Testing

• All cattle, llamas and alpacas exhibited at NY county fairs or the State Fair must be negative to an approved test appropriate to detect Bovine Viral Diarrhea persistent infection (BVD-PI). The testing veterinarian is responsible to make sure the proper test is conducted. This is a once in a lifetime test that must be reported on the required certificate of veterinary inspection. The issuing veterinarian is responsible for verifying the validity of the test, the identification of the animal and recording the test date on the CVI. If a previous test is not verifiable the test must be repeated.

Cleaning and Disinfection

 All buildings on the fairgrounds housing animals must be cleaned and disinfected prior to the opening of the fair and between groups of animals when housing is rotated (Section 50.2 of Agriculture and Market regulations).

Animal Deaths

Occasionally animal deaths occur at a fair.
 If a death it must be reported to the state veterinarian in charge as soon as possible for review. The animals must be promptly removed from the public exhibit area to a secure location and held for veterinarian prior to disposal.

Calving, Kidding and Lambing

• Any cattle, goats, or sheep that calve, kid, or lamb while at a county fair or the State Fair

will be ordered removed from the fairgrounds along with their offspring, unless the animals are part of a birthing demonstration.

Commingling of Sheep and Cattle

• Due to the potential spread of malignant catarrhal fever from sheep to cattle, it is strongly recommended that cattle be kept separate from sheep.

Commingling of Swine and Poultry

• Due to the potential spread of influenza viruses it is recommended that swine and poultry be housed in separate locations.

Isolation on Returning Home

• The owner or custodian shall keep show animals biologically separate from the herd or flock for a period of at least two weeks after returning to the premises of origin. If any illness is noted in the exhibition animals the owner should contact their veterinarian immediately.

INDIVIDUAL SPECIES REQUIREMENTS

Horses

- Certificate of Veterinary Inspection (CVI) is not required for New York origin horses. CVI is required for imported horses. Extended Equine CVIs (EECVIs) are acceptable. For more information on EECVIs, visit http:// www.globalvetlink.com.
- Negative Equine Infectious Anemia (EIA) test is required for all horses 6 months of age or older. The horse must be accompanied by a valid negative EIA test record. The sample collection date for qualifying EIA test must have been on or after January 1, 2018 for New York origin horses. For imported horses, the EIA the test must be conducted within 12 months prior to entry.
- The EIA test certificate must include a complete description of the horse.
- Rabies vaccination is required for all horses 4 months of age or older (see above).

Cattle

- Certificate of Veterinary Inspection with animals properly identified (see Animal Identification section above).
- Rabies vaccination is required for all cattle 4 months of age or older (see above).
- All cattle must be must be negative to an

- approved test appropriate to detect Bovine Viral Diarrhea persistent infection (BVD-PI). The date and results of the testing must be noted on the certificate of veterinary inspection.
- All cattle must be vaccinated against bovine respiratory disease complex including bovine respiratory syncytial virus, bovine virus diarrhea, infectious bovine rhinotracheitis and parainfluenza with a product administered in a manner and time frame adequate to confer protective immunity for these diseases for the duration of the fair.

Sheep

- Certificate of Veterinary Inspection with animals individually identified with USDA approved I scrapie identification. Identification must be one of the following:

 1) USDA approved tags or 2) a legible USDA approved flock tattoo and individual animal ID number or 3) electronic implant device (microchip) if the sheep is enrolled in the Scrapie Flock Certification Program. For information on scrapie ID, contact USDA at 1-866-USDA-TAG (1-866-873-2824).
- Rabies vaccination is required for all sheep 4 months of age or older (see above).
- The CVI must contain a written statement from the issuing Category 2 accredited veterinarian that the flock of origin was inspected after May 1 of the current year and no evidence of contagious, infectious or communicable diseases was found.
- If evidence of soremouth (contagious ecthyma) is found on any sheep, the entire exhibit including the affected animals shall immediately be removed from the fair premises with the holding pens cleaned and disinfected immediately after removal.

Goats

• Certificate of Veterinary Inspection with animals individually identified with USDA approved scrapie identification. Identification must be one of the following: 1) USDA approved tags or 2) a legible registration tattoo or 3) a legible USDA approved herd tattoo and individual animal ID number or 4) electronic implant device (microchip) if the goat is enrolled in the Scrapie Flock Certification Program and/or the electronic implant ID is recorded on the goat's registration paper. For information on scrapie ID, contact USDA at 1-866-USDA-TAG (1-866-873-2824).

- The CVI must contain a written statement from the issuing Category 2 accredited veterinarian that the herd of origin was inspected after May 1 of the current year and no evidence of contagious, infectious or communicable diseases was found.
- If evidence of soremouth (contagious ecthyma) is found on any goat, the entire exhibit including the affected animals shall immediately be removed from the fair premises with the holding pens cleaned and disinfected immediately after removal.

Swine

 Certificate of Veterinary Inspection with animals properly identified (see Animal Identification section above).

Llamas and Alpacas

- Certificate of Veterinary Inspection with animals properly identified (see Animal Identification section above).
- •All llamas and alpacas must be negative to an approved test appropriate to detect Bovine Viral Diarrhea persistent infection (BVD-PI). The date and results of the testing must be noted on the certificate of veterinary inspection.

Poultry

- Poultry (with the exception of doves, pigeons and waterfowl) must be accompanied by 1) results of a negative pullorum typhoid test conducted within 90 days prior to exhibition OR 2) proof that the birds originated directly from a US pullorum-typhoid clean flock or equivalent flock.
- Pullorum qualified by 90 day test must be identified by official leg band.
- Proof of NPIP status must be in the form of an NPIP certificate or purchase receipt containing NPIP certification information. If utilizing a receipt it must be dated within 1 year of the date of admission to the fair.

Deer/Elk (Cervidae)

- Certificate of Veterinary Inspection with animals properly identified (see Animal Identification section above).
- Originate from a herd classified as accredited or qualified under USDA tuberculosis regulations.
- A movement permit obtained from the Division of Animal Industry is required for all deer movements. All CWD and TB program requirements must be met before a

permit will be issued. Questions regarding movement permits should be directed to the Division of Animal Industry at 518-457-3971

Miscellaneous Ruminants

• Certificate of Veterinary Inspection with animals properly identified (see Animal Identification section above).

Exhibitor Prefair Guidelines

Cattle, Sheep, Goats, Swine, Llamas and Alpacas, Cervids, Misc. Ruminants

- Review the animal health requirements booklet including information for your species **before** your veterinarian arrives to inspect your animals. If you have any questions **ask.**
- Your veterinarian is responsible for inspecting your animals and completing the certificate of veterinary inspection (CVI). Call **early** to avoid the last minute rush when mistakes are made and there is no time to correct.
- Make sure **840** eartags(RFID or visual) are present on cattle and swine and USDA approved scrapie ID is in place on sheep and goats.
- Llamas and alpacas require a microchip or eartag. If a microchip is utilized make sure the veterinarian confirms the microchip ID or places one. If your animal is identified by a microchip, make sure you bring a working reader with you to the fair.

• ALL IDENTIFICATION MUST BE RECORDED. Make sure it is.

- Review the CVI carefully upon receipt to make sure all the information is correct including any required test or vaccination information.
- DO NOT stuff it in an envelope and assume all is well. The time to correct is before pulling them out at the fair. The CVI is your document and you share responsibility if it is incorrect.
- If you are **importing** livestock from out of state make sure the interstate requirements are met and you have a valid **interstate certificate of veterinary inspection.**

Poultry

• Schedule pullorum flock inspection and testing well ahead of the fair if your flock is participating in the NPIP program.

- If you're having your birds tested within 90 days of the fair you must go to a pullorum clinic. Available clinics are listed on the Dept. website. No individual testing is available if you miss a clinic.
- Birds qualified by 90 day test must be identified by official leg band.
- Bring documentation with you to the fair in the form of a 1) current NPIP certificate, 2) 90 day test chart or 3) purchase receipt with

NPIP certification within 1 year of the date of admission to the fair.

Horses

- NY origin horses must be accompanied by a negative EIA test report. The date of sample collection for the qualifying EIA test must have been on or after January 1, 2018.
- Imported horses must be accompanied by an interstate certificate of veterinary inspection with a **negative EIA test within** 12 months. Rabies vaccination information can be incorporated into the CVI.
- Drawing or photograph **must** match the horse.
- Rabies vaccination must be within 1 year of arrival at the fair and be documented by a **signed** rabies certificate or a **signed** statement on the EIA test chart with the required information (see requirements).

MOST IMPORTANT

When you are loading your livestock for the trip to the fair take the time to examine them. Make sure they are the same animals that are on the paperwork and if they are showing any signs of illness **LEAVE THEM HOME**.

CLINTON COUNTY FAIR HORSE SHOW RULES:

All eligible animals that are being exhibited at the Clinton County Fair must be vaccinated for rabies. All horses must be immunized within 365 days prior to the opening of the fair, which will help insure the animal against rabies while on the fair grounds.

New York State law now requires

all youth 18 years old and younger to wear an approved riding helmet while riding and handling horses. It is recommended that all wear an approved helmet. NO YOUTH 18 OR YOUNGER WILL BE ALLOWED TO RIDE WITHOUT APPROVED HELMET. Good sportsmanship is expected. Any person or persons exhibiting Poor sportsmanship may be asked to leave. All exhibitors must think SAFETY first and be ready for the unexpected. Any horse or rider not considered safe will be excused from the class.

GENERAL RULES

- 1. No entries will be accepted without a valid NEGATIVE COGGIN (this test must be in the calendar year for 2020 or 2021 at the time of entry), as required by NYS law. Anyone mailing entries must include a copy of the negative Coggins and rabies certificate. Horses / ponies will not be allowed to unload without proof of coggins & rabies. Horses from out of state are required to have 30 day health certificate.
- All entries in **breed** class must show registration papers at time of entry. Any mailed entries must include copy of registration papers.
- 3. All classes will follow ASHA, AQHA, ApHC and APHA.
- 4. Judges decision is final.
- 5. Horses are not allowed on the

- racetrack, airport, or midway at any time. Horses may come in on Thursday, July 29, 2021 at 1pm.
- 6. Horses must be on exhibit by 9:00 AM Friday, and must remain on exhibit until Sunday at 6:00 PM. Any entrants who do not comply with this rule are subject to denial of entry the following year.
- 7. Entries will be taken at the fair office until Saturday, July 24, 2021 before the fair starts. NO HORSES MAY BE ENTERED AFTER SATURDAY.
- 8. The show booth must be notified of any scratches or tack changes. THERE WILL BE A 2-MINUTE CALL FOR EACH CLASS AND THEN THE CLASS WILL BE CLOSED.
- Classes will be split based on size.
 Top picks from each split will be judged for final placing.
- Anyone entered in Section X(Maiden Division) cannot enter other classes except halter & showmanship classes.
- 11. For horse show purposes the age of the individual on January 1st shall be maintained for the entire year.
- 12. For horse show purposes the age of a horse shall be computed based on the year foaled starting on Jan. 1st.
- 13. Numbers will be (horses & rider combination) available at the fair office until Saturday before the fair begins.
- 14. Stalls will be assigned on the day of the show. NO RESERVATIONS WILL BE TAKEN. No tack stalls will be assigned until all horses have been accommodated.
- 15. There will be no smoking or drinking of alcoholic beverages in the barns.
- 16. There will be no cross tying in the aisles of the barns.
- 17. It is expected that all exhibitors keep the barns clean and the aisles clear of any hay or equipment.
- 18. If # of horses outnumber stalls available, you may be asked to trailer your horses into the show.

SECTION 1 HALTER DIVISION

Horses will be shown at a walk and jog or trot. Horses will be judged on type, conformation, quality substance, and soundness. Hereditary or transmissible unsoundness shall disqualify a horse.

Judges should emphasize free movement and manners. These classes will be judged on the performance, condition and conformation of the horse.

HUNTER

Schooling over obstacles on any part of the outside course is permitted only at the time designated by the show committee. Courses will be posted one hour before each class begins. To be

judged on manners, way of going and style of jumping. Horses shall be credited with remaining and even hunting pace that covers the course with free flowing strides. Preference will be shown to horses with correct jumping style that meets fences squarely. Judges shall penalize unsafe jumping and bad form over fences. Both horses and ponies may show in this division. Hunter Hack (2 jumps on outside course not to exceed 2'6".

Entries must also extend to trot and hand gallop.

Hunter Over cross rails.

Low Hunter over fences

(Max. height 2'3")

Working Hunter over Fences

(Max. Height 3')

<u>Junior Equitation over Fences</u> (riders 18 and under)

SECTION IV RANCH CLASSES

Western attire and tack should be clean and presentable. Working tack is encouraged.

- 1. Hoof polish is discouraged but will not be penalized.
- 2. Braided or banded manes discouraged but will not be penalized. No tail extensions.
- 3.Trimming inside ears is discouraged but will not be penalized.
- 4. Trimming bridle path, fetlocks or excessively long facial hair is allowed.
- 5. Equipment with silver should not count over a good working outfit. Silver bridles and saddles are discouraged but will not be penalized.

RANCH RAIL CLASS PLEASURE

A. This class is intended as a rail class but individuals working off the rail will not be penalized.

B. The ranch rail pleasure class measures the ability of the horse to be a pleasure to ride while being used as a means of conveyance from one ranch task to another and should reflect the versatility, attitude, and movement of a working horse. The horse should be well-broke, relaxed, quiet, soft and cadenced at all gaits. The horse should be ridden on a relatively loose rein with light contact and without requiring undue restraint. The horse should be responsive to the rider and make timely transitions in a smooth and correct manner. The horse should be soft in the bridle and yield to contact. The ideal ranch rail horse should have a natural head carriage at each gait. In all gaits, movement of the ranch rail pleasure horse should simulate a horse needing to cover long distances, softly and quietly, like that of a working ranch horse. This class should show the horse's ability to work at a forward, working speed while under control by the rider. Light contact should be rewarded and horse shall not be shown on a full drape of reins. The overall manners and responsiveness of the horse while performing the maneuver requirements and the horse's quality of movement are the primary considerations an above level topline with a bright, attentive expression.

D. Ranch Rail Pleasure Penalities

A contestant shall be penalized each time the following occur:

- 1. Too slow/ per gait
- 2. Over-bridled
- 3. Out of frame
- 4. Break of gait at walk or jog for 2 strides or less
- 5. Break of gait at walk or jog for more than 2 strids
- 6. Break of gait at lope
- 7. Wrong lead or out of lead
- 8. Draped reins
- 9. Out of lead or cross-cantering more than two strides
- 10. Trotting more than three strides when taking lead
- 11. Bleatant disobedience (kick, bike,

buck, rear, etc)

- 12. Major disobedience or schooling
- 13. Spurring in front of cinch
- 14. Use of either hand or instill fear/praise

RANCH RIDING CLASS RULES

The ranch riding horse should reflect the versatility, attitude and movement of a working horse. The horse's performance should simulate a horse riding outside the confines of an arena and that of a working ranch horse. This class should show the horse's ability to work at a forward working speed while under control by the rider. Light contact should be rewarded and horse shall not be shown on a full drape of reins. The overall manners, responsiveness of the horse while performing the maneuver requirements and the horse's quality of movement at the primary considerations.

Class Requirements

- 1. Each horse will work individually, performing both required and optional manevers and scored on the basis of 0 to 100, with 70 denoting an average performance.
- 2. The overall cadence and performance of the gait should be as those described in GAITS, with an emphasis on free-flowing and ground coviering forward movement for all gaits. Transistions should be performed where designated, with smoothness and responsiveness.
- 3. No time limit.
- 4. Posting at the extended trot is acceptable.
- 6. Only one hand may be used on the reins, except for junior horses shown with an acceptable snallfe bit or hackamore/bosal. Hands must not be changed. Hands to be around reins. One finger between reins permitted when suing split reins only. While horse is in motion, hands shall be clear of the horse and saddle except that is permissable to hold the saddle horn with either hand.

RANCH RIDING PENALTIES

1. One (1) point penalties

- a. Too slow/ per gait
- b. Over-bridled
- c.Out of frame
- d. Break of gait at walk or jog for 2 strides or less
- e. Split log at lope
- 2. Three (3) point penalties
 - a. Break of gait at walk or jog for more than 2 strides
 - b. Break of gait at lope
 - c. Wrong lead or out of lead
 - d. Draped reins
 - e. Out of lead or cross cantering more than 2 strides when changing leads
 - f. Trotting more than 3 strides when making simple lead change
 - g. Sever distrubance of any obstacle
- 3. Five (5) point penalties
 - a. Blatnat disobedience (kick, bite, buck, rear, etc.) for each refusal
 - b. Use of either hand to instill fear or praise
- 4. Placed below horses performing all maneuvers (OP)
 - a. Eliminates maneuver
 - b. Incomplete maneuver
- 5. Zero (0) Score
 - a. Illegal equipment (tail extenstions)
 - b. Willful abuse
 - c. Major disobedience or schooling
- 6. No specific penalities will be incurred for nicks/hits on logs but a deducation may be made in the maneuver score.
- 7. No specific penalties will be incurred for over/ under spins but a deduction may be made in the maneuver score.

SECTION V WESTERN HORSE DIVISION
